No changes in geometry of the impounding structure were noted since the 2019 annual inspection.  |

Impounded water is estimated to have varied in depth between 0 and 12 feet (1,230 ft to 1,242 ft mean sea level (ft MSL), respectively) since the previous annual inspection. The approximate water elevation at the time of inspection was visually estimated to be at 1237.75 ft MSL, which corresponds with a maximum estimated depth of 7.75 ft.  The estimate of the approximate minimum, maximum and present depth of CCR in the Impoundment ranges from approximately 9 to 29 feet (1,230 ft MSL to 1,242 ft MSL), based on the estimated base of the Impoundment. |
